Dear TIES members

Italy

The work of TIES members in 2009 has been very intense. We had many participants in our annual Conference TIES-GRASPA 2009 in Bologna on "Handling complexity and uncertainty in environmental studies" - almost 150 amongst the old and new members, 42 student members, together with a number of non TIES members, all contributing to the high scientific level of the Conference. I take the opportunity to thank both the Local Organizers of the Conference for having facilitated, by fostering a charming and friendly atmosphere, the scientific interaction among participants. I also wish to thank the Scientific Committee for their efforts in building up a remarkable program. Twenty-five papers have been recently submitted for the special issue of Environmetrics that followed the Conference.

I trust that the next 2010 Conference, organized in Margarita Island from 20 to 25 June by Lelys Guenni on "Sustaining our environment under changing conditions: quantitative methodological challenges" will be a success as well.

TIES has also entered the International Statistical Institute (ISI) family as a Section, and this has lead to a number of initiatives. In order to synchronize better with the ISI the terms of our society's officers were altered: the Board of Directors and the Annual General Meeting decided to prolong the service of the present Board members for one year, until August 2011.

Our North-American representative Tillman Gneiting had to resign and has been replaced by Brian Gray since September 2009. At the TIES 2009 meeting all TIES Committees were renewed as follows: a) Program Committee: Don Stevens (chair), Sylvia Esterby, Francesca Bruno; b) Election Committee: Daniela Cocchi (Chair) Ian McNeill, Ray Correll; c) Publications Committee: Michael Dowd. (Chair) Alessandro Fassò, Sylvia Esterby, Abdel El-Shaarawi, Peter Guttorp, Don Stevens; d) Membership Committee: Don Stevens (chair), Ulla Holst, Tim Gregoire; e) Awards Committee: Reinhald Viertl (Chair), Petra Kuhnart, Carlo Trivisano; f) Liaison and outreach committee: Daniela Cocchi, Don Stevens, Ron McRoberts, Ashley Steel, Hao Zhang.

The Editorial Board of our Newsletter has been reinforced and is now made up of: Michael Dowd (editor), Rosalba Ignaccolo and Alexandra Schmid (co-editors), together with Andrew Finley, Duncan Lee, Finn Lindgren, Melissa Dobbie and Laure Malherbe. The work of this enhanced board will permit to have at least two issues per year, and more articles in the newsletter.

At the end of October, myself and Secretary Alessandro Fassò met ISI President Jef Teugels and Director Ada Van Krimpen, together with their staff. We are working (helped by our Treasurer Sylvia Esterby) to facilitate the future of TIES as an ISI Section, while maintaining the history and unique aspects of our Society. One example is collection of membership fees: 2010 fees for members who renewed until 2009 will be collected via ISI, while TIES will renew contacts with people that interrupted payment after 2008.

Individual subscription to Environmetrics will be possible for 2010, according to the existing contract with Wiley. In addition, Wiley offers us a number of free tokens for downloading single articles of the journal: instructions for exploiting this opportunity will be given very soon.

In 2009, one regional activity has been TIES North American Regional Meeting, June 15-17, 2009, Corvallis, Oregon, USA, on *Measuring*, TIES NEWSLETTER, VOL. 15, NO. 1, December 2009 Monitoring, and Modeling Environmental Resources; Regional activities for 2010 and 2011 are still under discussion.

At ISI 2009 in Durban, South Africa, TIES was included for the first time in the activities of Sections, and participated in discussions about ISI restructuring. The Sessions organized by TIES, with the General Topic Committee or with other Sections, attracted a large audience. TIES is involved in the organization of the next 2011 ISI Conference in Dublin: our delegates for the program are Bronwyn Harch (main delegate), Abdel El-Shaarawi, Peter Guttorp and Marian Scott. Abdel El-Shaarawi is organizing a full day on *Water, Quantity and Quality,* which is part of the Dublin program.

TIES was also invited to organize a Session at XI CLAPEM, Latin American Congress in Probability and Mathematical Statistics, November 1-6 2009. At present we are organizing Sessions in conferences promoted by other ISI Sections, namely IAOS and ISBIS, also involving other Societies, as the French Statistical Society. A TIES Satellite Meeting will occur in 2010 (METMA5), at Santiago de Compostela.

Environmental issues are on the forefront of public discourse these days, and the role of statistics ought to become even more important. All suggestions for promoting environmental statistics from TIES members are most welcome.

# Order of the British Empire Awarded to Professor Marian Scott

Professor Marian Scott, TIES member and associate editor of Environmetrics, was awarded an Order of the British Empire (OBE) for her services to Environmental Science.

Dr. Scott works in the Dept of Statistics at the University of Glasgow as a Professor of Environmental Statistics. She sits on a number of government committees including the Scottish Environmental Protection Agency's Particles Retrieval Advisory Group (Dounreay) Scottish Government's Natural and the Environment Statistics Advisory Committee (NESAC). She is a chartered statistician of the Royal Statistical Society (RSS), a Fellow of the Royal Society of Edinburgh and Fellow of the International Statistics Institute. She is associate editor of a number of scientific and statistical journals and books including Journal of Environmental Radioactivity and Environmetrics.

# 2008 and 2009 Abdel El-Shaarawi awards Young Researchers Awards.

• 2008: Bronwyn Harch, CSIRO, Australia

Citation: For contributions to the construction of biological indexes for freshwater quality; for development of monitoring programs for water quality; for outstanding leadership and group building in CSIRO; for valuable contributions to TIES as conference organizer, treasurer, and board member.

• Alexandra Schmidt, Federal University of Rio de Janeiro, Brazil.

Citation: For contributions to spatio-temporal modeling of heterogeneous and nonseparable processes; for contributions to multivariate spatial statistics; for organizing workshops and short courses both nationally and internationally.

# **3.2 Meeting Reports**

**TIES 2009 - the 20th Annual Conference of The International Environmetrics Society and GRASPA Conference. Bologna, Italy, July 5-9, 2009** 

The 20th Annual Conference of The International Environmetrics Society was held at the Department of Statistics, University of Bologna, Italy, jointly with the GRASPA Conference 2009, under the common heading of "Handling complexity and uncertainty in environmental studies".

GRASPA (www.graspa.org) is the Italian Research Group for Statistical Applications to Environmental Problems, and the GRASPA conference was the final meeting of two Italian Projects (PRIN-MIUR-2006) on environmental statistics: "Statistical analysis and modeling of impact and risk for environmental phenomena in TIES NEWSLETTER, VOL. 15, NO. 1, December 2009 space and time" and "Methods for collecting and analyzing environmental data".

The conference had a very rich scientific program, with 4 plenary sessions, 26 invited sessions, 23 contributed sessions and 2 poster sessions, where 233 participants from 26 countries were involved (among them, 59 participants came from outside Europe). Participants had the opportunity to exchange opinions not only at the sessions, but also more informally at the on-site lunches as well as at the welcome reception, at the banquet and at the mid conference tours.

On July 4<sup>th</sup>, Sunday, 50 participants attended the short course on "Hierarchical Modeling and Analysis of Spatial-Temporal Data: Emphasis in Forestry, Ecology, and Environmental Sciences" given by Andrew O. Finley (Department of Forestry and Geography, Michigan State University) and Sudipto Banerjee (Division of Biostatistics, School of Public Health, University of Minnesota).

The conference was opened by the President's delivered Invited Lecture bv Walter Radermacher (Chief Statistician of the European Union and Director-General of Eurostat) on "Sustainable Economics: the contribution of official statistics". For the J. Stuart Hunter Lecture, established in 1996, Doug Nychka (National Center for Atmospheric Research) was designated for a talk about "Spatial statistics, computer models and regional climate change" (the talk was presented by Steve Sain, also of NCAR, due to an unpredictable last minute difficulty). Giovanna Jona Lasinio (University of Roma "La Sapienza") and Lorenzo Fattorini (University of Siena) gave the two GRASPA Invited Lectures on "Spatio temporal data modeling in environmental sciences: a review" and "Sampling strategies for the assessment of ecological diversity" respectively.

Modeling complex (count or spatial and temporal) environmental data was a central issue in several sessions, with a particular focus on computational aspects. Other methodological papers covered risk analysis, extreme values, point processes, change-point methods, nonparametric statistics, functional data and wavelet-based analysis, as well as chemometrics. Application areas were in air quality, water resources, forest fire and weather, ocean climatology, hydrology, palaeoclimatology, as well as environmental health and epidemiology.

The annual general meeting was held on Wednesday 7th, followed by the conference dinner held at the Complex of San Giovanni in Monte. During the dinner the traditional TIES award to the best poster and Abdel El-Shaarawi Young Researcher Award were conferred. Also a GRASPA Best Poster Award was presented, as well as other "serious but fun" awards to several participants.

The Social program included a welcome reception on Sunday evening, at the Department of Statistics, and a tour on Tuesday afternoon. Participants could choose between (i) hiking in the *Parco dei Gessi Bolognesi*, characterized by a series of gypsum outcrops and very interesting karst system, and (ii) the tasting of wine at the *Enoteca Regionale Emilia Romagna*, after visiting Dozza, a small medieval hilly village decorated with frescoes made by renowned artists and surrounded by wineyards.

### European Regional Meeting of the International Society for Business and Industrial Statistics 2009. May 30-June 3 2009.

The 2009 European Regional Meeting of the International Society for Business and Industrial Statistics (EURISBIS'09) was held in Cagliari and Santa Margherita di Pula, Italy, from May 30th to June 3rd 2009. The Scientific Program Committee was chaired by Vincenzo Esposito Vinzi (ESSEC Business School of Paris and Singapore; ISBIS Vice-President), Nick Fisher (Valuemetrics; ISBIS President) and Francesco Mola (University of Cagliari).

The scientific program comprised two Keynote Lectures, a Plenary Session, 21 Invited Sessions and 15 Contributed Sessions, in which approximately 110 people arriving from 18 different countries acted as speakers. Both Invited and Contributed Sessions focused mainly on statistical issues aimed at improving decisionmaking processes in Banking and Finance, Environment, Quality of Services for Small and Medium Enterprises (SMEs), Transport and Tourism.

Several TIES members were involved both in the organisation and in the scientific activities.

TIES President, Daniela Cocchi, acted as member of the Scientific Committee. Alessandro Fassò, TIES Secretary, held a keynote lecture entitled "Integrating satellite and ground level data for air quality monitoring and dynamical mapping" (Co-authors: F. Finazzi, C D'Ariano), TIES past president Anders Grimvall presented the talk "Simplicity as the ultimate sophistication in environmental management" in the session "Statistical analysis for decision support". An invited session was scheduled on "Statistics for health and environment", organised by Daniela Cocchi with talks of TIES members Annibale Biggeri, Fedele Greco and Rossella Miglio.

The next ISBIS meeting, ISBIS-2010 - Biennial International Conference of ISBIS: Portoroz,
